**Advertisement for Steering Committee Meetings for 2020**

Mr. Barnard said that the advertisement for the 2020 Steering Committee meeting schedule was printed in the January 21, 2020 Express Times edition. A copy of the legal affidavit is attached to the agenda and was also emailed to Steering Committee members.

**Press Release**

Mr. Barnard said the draft press release about the Issues and Opportunities report that was presented at the December meeting was revised, as requested, to include quotes from Committee Chairman Tom Petrucci, Northampton County Executive Lamont McClure, LVPC Executive Director Becky Bradley and CACLV Executive Director Alan Jennings. A copy of the revised press release is attached to the agenda. Mr. Barnard noted that The Morning Call also published an article about the report on February 2, 2020.

**Policy Development**

Mr. Barnard said that work on the policy section of the plan has begun. For the meeting, Committee members and members of the public in attendance were separated into three groups to focus the discussion on economic development in the Slate Belt. An exercise sheet was provided to each attendee to facilitate the discussion. Each group was asked to select a presenter and a note taker. The discussion focused on three main topics:

- What types of businesses are in the Slate Belt?
- What types of businesses are desired in the Slate Belt?
- What can be done to encourage business development in different areas?

An aerial map of the region was provided to each group to identify areas where businesses are currently located and areas where new businesses should be located. After an hour, each group reported out on their discussions to the larger group. All notes taken were collected at the end of the meeting and will be compiled to provide input on economic development policies.

**Next Steps**

Mr. Barnard said that the next few Steering Committee meetings will focus on workforce development, education and shared services, with representatives from these organizations to be invited for a group discussion.
